Backgrounder & Explanation of Questions

1. Thousands of underage girls, faced with an unplanned pregnancy, currently fall prey to the propaganda efforts of the abortion industry and terminate their baby, often without the benefit of discussion and counseling, or even the prior knowledge of the girls' parents.
2. Often, the decision to obtain an abortion is made hastily and under duress. Under current federal law, abortion clinics are not even required to inform a woman about the medical and psychological risks involved in destroying her unborn child.
3. Studies show that 78% of the mothers who see a sonogram of their baby ultimately reject abortion and choose life. That's why, although abortionists use sonograms themselves to perform abortions, they typically refuse to show the image to the mother unless forced to.
4. Female victims of abortion outnumber baby boys by as high as a three-to-one margin -- a statistic ignored by many self-styled "feminist" pro-abortion advocates.
5. Every fiscal year, countless efforts are made by the pro-abortion lobby and their political allies to insert abortion-funding language into state budgets nationwide.
6. ObamaCare still forces states to use taxpayer funds to cover abortions by cynically classifying them as women's "health care services." States will be required to use state and federal funds to provide abortions unless they enact state legislation to prevent it.
7. The RU-486 abortion drug has already been used to kill millions of unborn children. It was licensed by skipping normal approval procedures and categorizing pregnancy as a "disease." Under Presidents Obama and Biden, the FDA then obliterated the few remaining safeguards making it available by mail. This has permitted pregnant mothers to self-administer with little counsel or protection.
8. "Dilation and extraction (D&E) abortion" is perhaps the most horrific form of infanticide available under the law. During a D&E or dismemberment abortion, the abortionist tears the unborn baby completely apart before removing the tiny body piece by piece.
9. Many state legislatures and state courts are creating "rights" to abortion-on-demand under state law. A Human Life Amendment to the U.S. Constitution, once ratified by enough state legislatures, would permanently protect all unborn children from dying at the hands of abortionists.
